centerline presumption /centerline prɪˈzʌmpʃən/ n.
a rule almost all states recognize in some form, which presumes that landowners whose property adjoins a railway own to the centerline of the railway.
claims book /kleɪmz bʊk/ <b>n</b> .
a compilation of documents required to show the federal government's liability in the takings case including the current deed, current tax bill, a map of the property, a map of the railroad line, the deed by which the railroad acquired an interest in the property.

easement /ˈiːzmənt/ n.
a right to use someone else's land for some purpose.
Ff
fee simple /fi: 'sɪmpl/ n.
a type of interest in land; when someone holds title to land in fee simple, the land is owned completely, without limitation or condition, by the landowner.
fifth amendment /fɪfθ əˈmɛndmənt/ n.
an addition to the United States Constution providing, among other things, that the federal government cannot take private property for public use without paying just compensation.

inverse condemnation /In'va:s kondem'neIsən/ n.

an act when the federal government takes private property without paying the compensation required by the Fifth Amendment of the United States Constitution.

### Jj

just compensation /ʤʌst ˌkɒmpɛnˈseɪʃən/ n.

the fair market value of the property taken.

### Nn

national trails system act /'næʃənl treɪlz 'sɪstɪm æktv/ n.

a piece of federal legislation allowing for the conversion of abandoned railroad corridors into recreational trails, and setting forth the process and requirements for such conversion.

notice of interim trail use /'nəʊtɪs ov 'ɪntərɪm treɪl juːz/ n.

the document issued by the Surface Transportation Board which formally authorizes conversion of a railway into a recreational trail and the issuance of which triggers the Fifth Amendment taking; also known as the NITU.

railbanking /railbanking/ v.

the process when an abandoned railroad is converted into a recreational trail, preserving the railroad corridor for potential future use as a railroad, but, in the meantime, allowing a recreational trail to be constructed where the railroad used to be.

### Ss

surface transportation board /'ss:fis\_trænspo:'teɪ[ən boːd/ n.

a federal agency, also known as the STB, with jurisdiction over regulation of surface transportation, including railroads.

### Tt

taking / teɪkɪŋ/ v.

an act when the government seizes private property for public use.

#### Uu

united states court of federal claims /jo'naɪtɪd steɪts koːt ɒv 'fɛdərəl kleɪmz/ n.

a United States federal court, established by Congress in 1855, authorized to allow citizens to file claims for money against the federal government.
